No.SCS-401/6/2025-MAHUD-MAHUD/6: Whereas, Town Planning Department, Manipur in collaboration with the Kwakta Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Kwakta Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Kwakta Municipal Council in its meeting held on 05.12.2024 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Kwakta Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Bishnupur in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED KWAKTA MUNICIPAL AREA

Starting from the north-eastern corner of C.S. Dag No. 5035, Village No. 91 Kwakta, Sheet No. 6 (Ward no. 1) the boundary line goes east along the northern boundaries of C.S. Dag No. 5226 and the line goes south along the road covering C.S. Dag Nos. 5269, 5330, 5325, 5324, 5430, 5424, 5419, 5576 and 5632. The line continues towards west along the canal covering the southern boundaries of C.S. Dag no. 5631 and then goes towards south along the eastern boundaries of C.S. Dag No. 5630, 5648 and continues southwest covering the southern boundaries of C.S. Dag Nos. 5649, 5650, 5651, 5652, 5653, 6554, 5576, 5579, 5578, 5576, 5575, 5574, 5573, 5567, 5565.

The boundary line continues towards Village No. 99 Kwakta, Sheet No. 7 covering the southern boundaries of C.S. Dag No. 6323 and goes south covering the eastern boundaries of C.S. Dag No. 6407, 6403, 6402 and goes west covering the southern boundaries of C.S. Dag No. 6402, 6395, 6392 and goes north covering the western boundaries of C.S. Dag No. 6392, 6405 and continue north covering the southern boundaries of C.S. Dag No. 6324. Further, it goes north covering the eastern boundaries of C.S. Dag No. 6324 and turn east along the southern boundaries of C.S. Dag No.6321, turn west along the northern boundaries of C.S. Dag No. 6321 and moves towards north along the C.S. Dag No. 6320, 6325. The boundary line towards west along the southern boundaries of C.S. Dag No. 6300, 6299, 6272, 6298, 6273, 6274, 6275,6276, 6280, 6281, and moves towards north along the western boundaries of C.S. Dag No. 6281, 6277, 6101, 6063, 6062, 6438, 6439, 6060, 6058, 6044, 6041. The line continues east along northern boundaries of C.S. Dag No. 6041 eastern boundaries of 6041, northern boundary of 6113, then line goes north along the western boundaries of C.S. Dag No. 6117, 6118, 6185, 6183, 6182 and move towards east along the northern boundaries of C.S. Dag No. 6182, 6190, 6198, 6199, 6216, 6424 and 6205.

Further the boundary line continues towards Village No. 91 Kwakta, Sheet No. 6, covering the western boundaries of C.S. Dag Nos. 5110, 5021 then continues towards Sheet No.7 Village No. 91 Kwakta, C.S. Dag Nos. 6171, 6201, and again goes towards Sheet No. 6, Village No. 91 Kwakta, continues towards north covering the western boundaries of C.S. Dag Nos. 5020, 5024, 5025, 5026,5028, 5032, 5033, 5036 and meeting the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED KWAKTA MUNICIPAL AREA

WARD NO. 1

Starting from north eastern corner of C.S. Dag No. 5035 of Kwakta village No. 91, Sheet No. 6, the ward boundary line goes towards east along the northern boundaries of C.S. Dag Nos. 5222, 5226 and 5268 and the line goes south covering Dag Nos. 5269 ,5330 and 5332. Then the line goes towards west covering C.S. Dag Nos. 5406, 5247, 5248, 5228, 5229, 5029, 5028 and continues towards north covering western boundaries of C.S. Dag Nos. 5028, 5032, 5033, 5036 and meeting the starting point.

WARD NO. 2

Strating from north western corner of C.S. Dag no. 5763 of Village No. 91 Kwakta, Sheet No. 6, the boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 5231, 5245, 5246, 5243, 5265, 5768, 5240, 5239, 5238, 5337, 5333, 5334, 5335, 5338, 5339, 5324, and 5325 and continues towards south covering C.S. Dag Nos. 5325 and 5324. Further the line goes towards west along the road covering southern boundaries of C.S. Dag Nos. 5342, 5235, 5233, 5232, 5230 and crosses the road. The line continues west along the canal covering southern boundaries of C.S. Dag Nos. 5023, 5103, 5104, 5105 and 5106 and then continues towards west covering the southern boundaries of C.S. Dag no. 6171 and 6201 of Village No. 91, Kwakta, sheet No. 7. The line continues towards north covering the western boundaries of C.S. Dag Nos. 5020, 5024, 5025 and meeting the starting point.

WARD NO. 3

Starting from northwestern corner of C.S. Dag. No. 5382 of Village No. 91, Kwakta, Sheet No. 6, the ward boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 5381, 5378, 5377, 5376, 5375, 5374, 5372, 5371, 5370, 5369, 5365, 5360, 5363, 5355, 5353, 5352, 5347, 5345, 5430 and continues south covering the eastern boundaries of C.S. Dag Nos. 5430, 5424 and 5419. Further the line goes west covering the southern boundaries of C.S. Dag Nos. 5419, 5420, 5422, 5423, 5424, 5425 and 5401 and continues northward covering the western boundaries of C.S. Dag Nos. 5387, 5386 and meeting the starting point.

WARD NO. 4

Starting from northeastern corner of C.S. Dag No. of 5602 of Village No. 91 Kwakta, Sheet No. 6, the ward boundary line goes towards south along the road covering eastern boundaries of C.S. Dag Nos. 5576, 5632 and the line continues towards west along the canal covering the southern boundaries of C.S. Dag No. 5631 and goes towards south along the eastern boundaries of C.S. Dag Nos. 5630, 5648 then continues southwest covering the C.S. Dag Nos. 5649, 5650, 5651, 5652, 5653, 5576. The line goes towards north covering the western boundaries of C.S. Dag Nos. 5586, 5585, 5591, 5592, 5594, 5617, 600 and continues east along the road of C.S. Dag Nos. 5601 and meeting the starting point.

WARD NO. 5

Starting from northwestern corner of C.S. Dag No. 5475 of Village No. 91 Kwakta, Sheet No. 6, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 5491, 5492, 5493, 5499, 500 and 501, and continues towards south covering the eastern boundaries of C.S. Dag Nos. 599, 598, 5597, 5595, 5514, 5512 and 5513. Further the line goes west covering the southern boundaries of C.S. Dag Nos. 5513, 5549 and 5520, and then continues towards north along the road covering western boundaries of C.S. Dag Nos. 5521 and 5474, and meeting the starting point.

WARD NO. 6

Starting from Northwestern corner of C.S. Dag No. 5429 of Village No. 91 Kwakta, Sheet No. 6, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 5434, 5472 and 5473, and continues towards south covering the eastern boundaries of C.S. Dag Nos. 5473, 5764, 5471, 5470, 5469, 5468, 5467, 5522, 5523 and 5524. Further the line goes towards west along the road covering southern boundaries of C.S. Dag No. 5525 and then continues towards north along the road NH. 2 covering western boundaries of C.S. Dag Nos. 5787, 5444, 5428, and meeting the starting point.

WARD NO. 7

Starting from northwestern corner of C.S. Dag No. 5527 of Village No. 91 Kwakta, Sheet No. 6, the ward boundary line goes towards east alongside the road covering northern boundaries of C.S. Dag Nos. 5528, 5533, 5534, 5536, 5538, 5546, 5548, 5549, 5551 and continues south covering eastern boundaries of C.S. Dag Nos. 5551, 5584, 5580 and 5579 then continues southwest covering the southern boundaries of C.S. Dag Nos. 5578, 5576, 5575, 5574, 5573, 5576 and 5565.

The boundary line continues towards Village No. 99 Kwakta, Sheet No. 7 covering the southern boundaries of C.S. Dag No. 6323 and goes south covering the eastern boundaries of C.S. Dag No. 6407, 6403, 6402 and goes west covering the southern boundaries of C.S. Dag No. 6402, 6395, 6392 and goes north covering the western boundaries of C.S. Dag No. 6392, 6405 and continue north covering the southern boundaries of C.S. Dag No. 6324. Further, it goes north covering the eastern boundaries of C.S. Dag No. 6324 and turn east along the southern boundaries of C.S. Dag No.6321, turn west along the northern boundaries of C.S. Dag No. 6321 and moves towards north along the C.S. Dag No. 6320, 6325, 6314, 6436, 6435, 6304, 6302 till it meets the starting point.

WARD NO. 8

Starting from northeastern corner of C.S. Dag no. 5787 of Village No. 91, Kwakta, Sheet No. 6, the ward boundary line goes towards south along the road NH.2 covering Dag no. 5131.

The line Continues west towards Village No. 91, Kwakta, sheet No. 7, covering the southern boundaries of Dag Nos. 6301, 6258, 6242, 6242, 6256, 6254, 6273, 6274, 6275, 6276, 6283, 6181 and goes towards north covering C.S. Dag Nos. 6277, 6101, 6063, 6062, 6439, 6438, 6439, 6060, 6058, 6053, 6044, 6041 and goes towards east along the road 6113 and meets the southwestern corner of C.S. Dag no. 6117 then continues northward covering western boundaries of C.S. Dag Nos. 6117, 6118, 6185, 6183, 6182 and goes towards east covering C.S. Dag no. 6190, 6198, 6199, 6216, 6204, 6205 of same village .

The line further continues towards Sheet No. 6 of Village No. 91, Kwakta, covering the northern boundaries of C.S Dag Nos. 5110, 5108, 5107 and goes south and meeting the starting point.

WARD NO. 9

Starting from the northeastern corner of C.S. Dag No. 6426 of Village No. 91 Sheet No. 7 goes towards south along the N.H. covering the eastern boundaries of C.S. Dag No. 6300 and goes towards west covering the southern boundaries of C.S. Dag No. 6272, 6298 then moves towards north along the western boundaries of C.S. Dag No. 6298, 6447, 6271 the line then moves east along the northern boundaries of 6271, 6257, 6265 western boundaries of 6246 till it meets starting point.
